## Public Input:

- Kevin Chen, Charlie Xiao, David Fang, Michael Wang, Jackie Yu, Kwan Ko, Adriana Quinones, Mr. Dudzak: Project Homekey & Homeless (PH&H), personal safety concerns, County not sharing or requesting input.
- Ray Humphreys: Shared attendees should attend a LA Co. BoS Meeting to voice their complaints, not direct those at the HHIA Board.
- As Scott Martin attempted to advise the attendees that Public Input (PI) on the topic of Project Homekey needed to end and other topics on community issues brought forward to continue with agenda items, HHIA board member Steven Wu and other board members demanded openly that additional PI should be heard. Martin stated he was trying to facilitate the meeting and that enough PI had been heard on the PH&H topic. Wu and Adriana Quinones demanded again more PI. Wu moved to the podium to speak. He demanded to "vote" on HHIA's "position" on PH&H. Martin immediately advised Wu there will be no vote at this time and it was inappropriate to suggest one. Wu was joined by board member Adriana Quinones, together overriding Martin's insistence to follow decorum and allow the meeting facilitator to move forward. Wu spoke towards to the attendees causing shouts from attendees. Martin gave a second 'warning' to Wu that the behavior would not be tolerated and another outburst by him or attendees will cause the meeting to end. Quinones insisted she be able to speak to which Martin invited her to give PI as a resident not as a board member.

❖ Presentation: Lisa Woung, LA Co. Public Works: Described in late July/early August PW wants to hold a community meeting, and additional meetings with the HHIA. Some details were provided re: the Leticia Drive et al Phase I & Phase II Project. She provided highlights on other projects. Requested to come back and present more to HHIA members in immediate future. Was told to reach out to John Ford to coordinate. A question was asked regarding how the county makes decisions to repair roads. The attendee cited she (Lucy Pedregon) has had no repairs to their street for 40 years. Lisa described where one can go to the Public Works webpage to locate a list of every street in HH and criteria used to rate streets for future repairs/projects.

\*No data/information to share with attendees was provided to the HHIA. Flyers were provided.

## **A** Community Representatives:

Representative 1st Supervisorial District: Ryan Serano offered information on a Bystander & Violent Offender training and offered further details regarding the remodel of the Project Homekey facility. Ryan and Daniella (sp) took criticisms from attendees over residents not having been made aware of "homeless shelter". Scott Martin/Board shared disappointment that the HHIA Board is taking brunt of anger/concerns and it is important that the Supervisor's office hear what is being shared.

Martin advised everyone that PI on PH&H as a topic was through and board members Wu, Quinones, and other board members demanded he speak. Martin invited the attendee (Mr. Dudzak) up with the caveat that the topic was not on PH&H. Attendee said it was not then proceeded to talk about PH&H.
