Public Safety & Law Enforcement Updates

LASD Industry Station: Deputy Jose Ruano & Lt. Tri Hoang

Lt. Tri Hoang introduced himself as Operations Lieutenant of the Industry Station.

Deputy Ruano reviewed the February crime stats. He shared activities the Sheriff's Department has assisted with including "security" in our hills. Monthly Crime Statistics Available on the HHIA Website Under Documents/Reports For This Month.

CHP Santa Fe Springs Station: Ofc. Kevin Tao

Ofc. Tao provided the board with his background with the CHP in the SFS station. He shared statistics on enforcement activities and that April will be Distracted Driving Enforcement Month.

Puente Hills Habitat Preservation Authority: Andrea Gullo shared what the PHHPA does for the community, activities they conduct, that they manage 3,800 acres, and described what the Rangers do. Andrea also described a possible fee/tax being considered. Community meetings will be held to share the concept and receive feedback.
