Knabe introduced motion at the Board of Supervisors to close the January 19<sup>th</sup> Meeting in memory of Mary Ann King, one of our community leaders, 2) Our Community Cooling Center, part of the Surviving the Heat Program, is the Steinmetz Senior Center for those who do not have or cannot afford Air Conditioning and discussed various tips from the Program (A copy of which will be posted on our website), 3) Taste of the Heights this year is at Pathfinder Park in Rowland Heights on July 28<sup>th</sup> at 6pm, 4) The Public Safety Appreciation Luncheon at Pacific Palms will be held on October 6<sup>th</sup> (more info to come) and the Hacienda Heights Connection magazine should be mailed the first week in July.
