### **Nomination and Election of Directors**

The HHIA Board of Directors are nominated and voted on as described below. Provided are the names of three incumbents and seven eligible HHIA members. Those incumbents are Andrea Gordon, John Ford, and Steven Wu. HHIA members nominated are Bala Venkataraman, Jess Montes, Alitzah Wiener, Ann Ellis-Hall, Michael Wang, David Fang, and Fong-Fei Lee. Three Board Members will end their terms: Geri Kleinpell & Scott Martin (termed out) and Randy Black & Cindy Greenup (choosing to step down from the board).

As a result there will be an election. Contained in this newsletter will be: a ballot containing instructions, an envelope to return your completed ballot in, and biographies of the incumbents and nominees. The Nominating Committee urges you as a member(s) to vote for <u>up to eight (8) names</u> on the ballot. We also urge you to vote soon and mail your completed ballot sealed in the provided envelope ASAP. Second option is to hand deliver your ballot envelope at the December 18, 2023, General Membership Meeting. Lastly, you can hand deliver your sealed ballot envelope when you arrive at the Annual Business Meeting.

2024 Election: Nominee Biographies

Nominee: R. Ann Ellis-Hall

Ann has been a resident of Hacienda Heights since 1981, for over 42 years. She is currently a Commissioner to the Assessment Appeals Board appointed by Supervisor Hilda Solis. Ann has been serving this community as a Broker/Realtor since 1992 and knows the needs of this community well. She is also an active member in many other community non-profits and organizations such as the Hacienda Heights Woman's Club, Hacienda La Puente Unified School District and the local Board of Realtors.

Nominee: David Fang

David has been a resident of Hacienda Heights for over 30 years. He is a practicing attorney and is a member of the American Bar Association and California Bar Association. He has served as an advisor of Congresswoman Judy Chu and former Calif State Treasurer John Chiang. In 2016 he was invited to the White House by President Obama. ### **HHIA Elections:**

Eight (8) Board Positions are open for election.

You may vote for eight or less candidates. Eligible candidates must have been an HHIA Member in good standing for at least 6 months prior to January 1, 2024. Each household is entitled to one (1) vote. In the case of a married couple or registered domestic partners living at the same address, only one (1) ballot may be placed in the envelope provided.

The ballot below must be placed in the enclosed HHIA self-addressed envelope. A Member must print their address and sign the return envelope in the upper left corner. This is only for the purpose of verifying your membership and can in no way be used to identify your ballot.

All ballots must be returned on or before the Annual Meeting on January 17, 2024. You may mail or bring the ballot to the Annual Meeting in the enclosed envelope. Only 1 ballot per household.

We urge you to exercise your right to vote. Those elected will represent the Hacienda Heights Improvement Association and our community, of which we are all a part.
