#### **Hacienda La Puente Unified School District**

A Reconfiguration Committee recommended that four schools be closed and other changes:

Los Robles Academy and Bixby Elementary located in Hacienda Heights will close.

Del Valle Elementary and Sunset Elementary located in La Puente will close.

## **CERT Training**

Community Emergency Response Team (CERT) training is a free resource that can help create a neighborhood preparedness network in your community. Taught by local fire and law enforcement agencies, this 20-hour FEMA approved training curriculum provides residents with information on basic disaster response skills such as fire safety, light search and rescue, team organization, and disaster medical operations. CERT members are encouraged to support first responders by becoming leaders in emergency preparedness in their community.

# **Quemetco/Ecobat**

The Board of Environmental Safety (Board) will hold a hybrid public hearing on the appeal of the Department of Toxic Substances Control (DTSC) Permitting Division's (Permitting) July 22, 2022, approval of a Temporary Authorization Request made by Ecobat Resources California, Inc. (Ecobat), formerly doing business as Quemetco, Inc.

### **Background**

Ecobat operates a facility that recycles lead from spent lead acid batteries and other lead-bearing materials. On February 11, 2021, Ecobat submitted a temporary authorization request to install two equipment units (compression auger and centrifuge) that can remove liquids from hazardous waste material. On April 19, 2021, DTSC approved Ecobat's temporary authorization request. The approval was appealed by Earthjustice on behalf of the Clean Air Coalition of North Whittier and Avocado Heights. On January 26, 2022, DTSC's Permit Appeals Officer granted Earthjustice's appeal and overturned the temporary authorization decision.

# 7th Avenue Village Project

7th Avenue Village is a proposed 142-unit permanent supportive housing project in the Hacienda Heights area of the County of Los Angeles with an anticipated completion of construction scheduled for late 2024; the property is a conversion of a former Motel 6 property at the site.

A HomeKey development with funding from the State of California and the County of Los Angeles, the property will offer housing with intensive supportive services to formerly homeless individuals, with a priority for homeless individuals in the surrounding area. Supportive case management services will be provided by our contracted partner, Housing Works.
